**Objectives:**

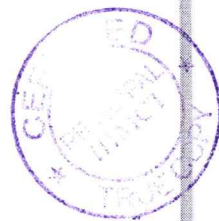
1. To establish mechanism to ensure a ragging free campus.

All students, teaching faculty and administrative staff come under the purview of this policy.

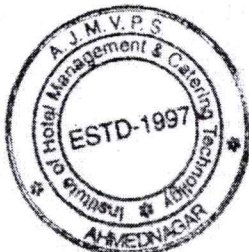
**Objectives:**


1. To prevent discrimination and provide an impartial, confidential and accommodating environment to all members of college.







**Introduction:**

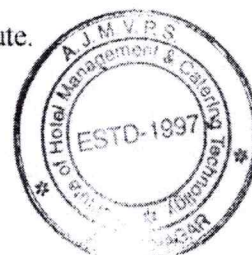

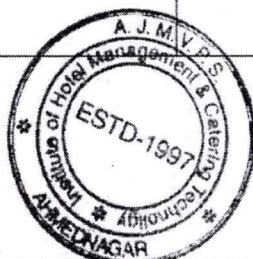


**Grievance Redressal Procedure:**
